ORDER

In pursuance of Article 235 read with 241-A of Punjab Education Code and order no. DSE-UT-A4-24(9)2020(F11)/3592 dated 28.06.2024, provisional recognition is hereby granted in favor of the **NORTHRIDGE INTERNATIONAL SCHOOL, SECTOR 46-A, CHANDIGARH** upto Secondary level for the period from 01.04.2025 to 31.03.2029, subject to the following conditions :-

1. The school shall abide by the provisions of Right of Children to Free and Compulsory Education Act 2009 and the Right of Children to Free and Compulsory Education Rules, 2010 and other instructions issued by the Education Department
2. For the children belonging to weaker section and disadvantaged group in the neighbourhood the school will provide free and compulsory elementary education till its completion. The school shall be reimbursed in accordance with the provisions of sub-section (2) of section 12 of the Act. To receive such reimbursements School shall maintain a separate bank account.
3. The society/school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
4. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority;
5. The school buildings or others structures or the grounds to be used only for the purposes of education and skill development;
6. The school is not run for profit to any individual, group or association of individuals or any other persons;
7. The school to furnish such reports and information as may be required by the Director of School Education/District Education Officer from time to time and comply with such instructions of the Appropriate Government as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school;
8. Reserve Fund to be maintained in the name of DEO, U.T., Chandigarh equal to 02 months salary of the teaching/non-teaching staff,
9. School to follow land allotment conditions and other notifications/orders/instructions issued by the Chandigarh Administration from time to time;
10. Salary to the teachers and other staff be paid as per provision of Appendix-I of CBSE affiliation Bye Laws;
11. School to follow the provision of Rules of Recognition of Punjab Education Code;
12. No particular book shop be prescribed for purchase of book/uniform etc. by the school and Instructions/guidelines issued by CBSE relating to books/uniforms to be followed;
13. Fire Safety Norms to be followed meticulously and there should be no laxity in this regard on the part of the school. The Fire Safety Certificate from the Fire Department, UT, Chandigarh be submitted to this office;
14. Staff engaged should be qualified as per NCTE notifications issued from time to time and untrained teachers should be replaced with trained ones;
15. Recognition is liable to be withdrawn if the management or the staff of the school take part in agitation against the authority of Government, or disseminate opinions tending to excite feelings of disloyalty or disaffection against Government or of enmity and hatred between different classes or if the pupils are permitted to attend political meetings or to engage in any form of political or communal agitation;
16. Government reserves to itself the right, to grant, refuse or withdraw recognition at its entire discretion.

17. The management will not add any more class/section to the school without the permission of the department;
18. The school will not be transferred to a different Managing Body already approved by the Department;
19. Renewal of Registration of Society, if any, be ensured.

The recognition is also subject to further the following conditions:-

- a) That as per provisions of Section 5 of the Punjab Regulation of Fee of Un-aided Educational Institutions Act, 2016 extended to the U.T., Chandigarh w.e.f. 13.04.2018, increase in fee shall not exceed eight per cent of the fee of the previous year;
- b) That admission of 25% students under EWS category and Disadvantaged Group students be made as per Section 12 of the RTE Act, 2009 upto 8th class and 15% from 9th Class to 10th Class as per Land Allotment Policy.
- c) That the teachers who do not fulfill the minimum qualifications as per NCTE guidelines need to acquire minimum qualification or replacing them with qualified teachers.
- d) That the School shall prepare its annual report for each academic year in the Form D under Rule 7 of "The Chandigarh Union Territory Regulation of Fee of Unaided Educational Institution Rules 2019" and submit the same to the DEO, UT, Chandigarh and copy to this office.

The school should ensure that all the above conditions be complied in letter and spirit failing which further recognition would not be considered.
